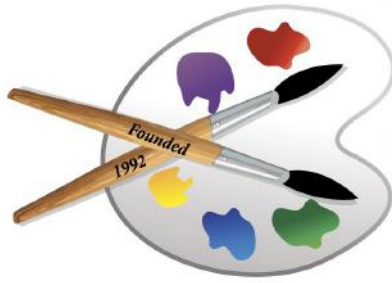

On the pages that follow, we report on the American Canyon Arts Foundation's programs, activities and events of the last twelve months. A financial summary and roster of Members is also included, consistent with our By-Laws. Combined, it represents the 2015 Annual Report.

Looking back over the last year, it has been demanding, but rewarding. At the beginning of the year, we struggled with the challenges of closing the Gallery and Art Center. We needed to identify a new mission and direction, as well as to generate new sources of revenue and manage our day to day expenses.

Now that the year is over, it is safe to say that our financial picture has improved markedly, and we continue to build and improve on our premier event, the Arts in April program. We are now ready to focus on the needs and interests of our membership, but not lose sight of our charitable responsibilities to our public schools and the community at large.

This year's Art Extravaganza was the biggest ever, with over 500 people enjoying the artwork and events. It was also our largest single fund raiser, netting over \$3500. This required the work of all of our members, but special recognition again needs to go to **Nathell Buford**, who curated the show and worked tirelessly to make it a success.

I also want to thank our Board of Directors, each of whom worked on several, if not all, of our events and programs. Those Directors are listed below:

## Summary of Events and Activities for 2015

### Napa Valley Arts in April program

Starting in 2014, the Foundation decided to merge our annual **Art Extravaganza** show with the County wide program managed by Visit Napa Valley and the Arts Council Napa Valley. For 2015, our programs included the juried Art Show, **Mario Chiodo** as our Guest Artist/Speaker, a tour of the future Town Center (aka, Napa Valley Ruins & Gardens), and several “pop up” art shows at local hotels and banks.

The Art Extravaganza and Guest Artist was held at beautiful **Jamieson Ranch Vineyards**, and they were an incredible host! Not only did they provide the facility, and host the Artist Reception, but they contributed beautifully decorated bottles of wine, which boosted our Silent Auction proceeds.

We had over 500 people enjoy the offerings, including a sellout crowd for Mario’s talk: “From Monsters to Monuments.” Almost 100 people signed up for the tours of the Town Center. Most impressive of all, we were able to net over \$3500 to go towards our charitable purposes.

Forty-three artists submitted a total of 137 pieces of art. Ribbon and cash awards were given to first place winners in each category, with ribbons given to second and third place. Best of Show went to **Hilda C. Robinson’s** pastel, “Rapid Transit.” People’s Choice went to **Penelope Moore’s** oil, “Old World Charm.” Our three judges for the event were **Mikey Kelly, Pam Dixon** and **Jeff Snell**.

Board member, **Nathell Buford**, curated the show for the second year. In addition to the many complements received, at least one art association contacted Ms. Buford for tips and insights for their shows.

### Shows and Receptions

The Foundation hosted a number of art shows and receptions in 2015. A brief listing is provided below.

- **Black History Month:** In February, pieces from the Nathell & Lawrence Buford Collection went on display at the Umpqua Bank in American Canyon.
- **Springhill Suites Reception:** For the second year in a row, Springhill Suites at the Airport hosted the Arts Foundation in May. Several of our artist members had their work on display and for sale.
- **Plein Art Workshop:** Water colorist, Rolando Barrero offered his expertise for an afternoon at the Town Center Ruins in June. It was a wonderful event, although a bit too hot!
- **Reception for Taylor Cleary, Student Scholarship Recipient:** We started a new tradition of hosting a reception for our annual Scholarship Winner. The event was held at the Umpqua Bank in August.
- **Welcome Center’s Grand Opening:** The Chamber of Commerce opened their Welcome Center in August and the Foundation was invited to exhibit some of their artist member’s works. There was a great turnout, including the Mayor of Calistoga! The Welcome Center has also agreed to provide space for our members to exhibit their works for sale.

- **Multi-Cultural Event:** This was actually produced by Arvind Nischal's Helping Hands organization, but the Foundation assisted with promoting the event, and some of its members were sponsors. The event was held at the City's Community Gym in October. It included performances from several of the ethnic groups of the American Canyon community, as well as food samplers.
- **Art Show featuring Janice Peterson:** Closing out the year was a one person show at the Umpqua Bank in October. Janice Peterson is one of our newer members, and we hosted the reception in her honor.
- **Other Art Shows:** We did not produce our Open Studios this year, but we did encourage our members to participate in the Open Studios of other cities in the area. Almost a dozen members were at the Vallejo Open Studios (including our People's Choice winner, Penelope Moore), and others were at the Napa Open Studios and Fairfield's two shows. In fact, Jennifer Atkinson-Lockette was the People's Choice winner at the Fairfield 52<sup>nd</sup> Annual Juried Art Show!

### **Community Support**

As a nonprofit organization, it is our duty to give back to the community. We do this in a number of ways:

- **Student Scholarship:** Each year, we give out a scholarship to a High School Senior who wants to pursue a career in the arts. This year the winner was Taylor Cleary, who is a music major. We also held a reception for her at the Umpqua Bank, something we will continue to do in the future. We also hope to raise more money to increase the amount of the scholarship, as well as to provide grants to our local schools to enhance their art programs.
- **Earthquake Relief:** After the devastating earthquake in India last summer, the Board decided to donate funds to help the victims. It was also a good way to work with local community supporter, Arvind Nischal's Helping Hands Nonprofit organization.
- **Community Special Events:** As in years pass, we hosted the Annual Chalk Art Contest as part of the City's Easter Festivities. We had another good turnout this year, and the event went very well. **Roberta Labaw** headed up the event, with help from several of the Board members. We also had a booth at the Fourth Of July event, and signed up several new members. We did not host the buses for the Decorated House contest this year, since we did not have the Gallery.
- **Public Art Campaign:** We also decided to support public art in American Canyon. The Board agreed to set a \$1000 fund raising goal towards the 9/11 Memorial Statue in American Canyon. Designed by famed Napa artist, Gordon Huether, this could become the first major public art piece for the City. Members are encouraged to make donations that the Board will then use Foundation funds to match. To date, we have generated almost \$300 from our members, and hope to reach \$500 by early 2016.

We also participated in the City's Public Art Master Plan efforts. Initially designed to establish a "One Percent for the Arts" fee, it shifted its focus to developing a Master Plan for the Arts: where art should be located, the types and formats to be used, selection processes and potential funding sources.

## **Marketing Grant**

In 2014 we received a grant from Napa County to develop a marketing plan and marketing materials. We contracted with Piazza Marketing Concepts, a local firm, to develop marketing guidelines and suggested materials. Using another local business, FastSigns, we re-designed our Logo and produced a variety of materials, from envelopes to marketing brochures to table covers with our logo on them! Overall, the net effect is to give us a more polished, professional look.

## **In Memoriam**

We cannot end this report without acknowledging the loss of two of our members: Faye Gonsalves and Cleven "Goodie" Goudeau.

- ***Faye Gonsalves***: Faye passed away on December 26, 2014. She had been a Board member and regularly donated time and money to the Foundation.
- ***Cleven "Goodie" Goudeau***: Goodie passed away on January 26, 2015. A longtime supporter of the arts in Vallejo, he taught classes for the Foundation and was an inspiration to many of our members.

Both members will be missed, not only by the Foundation but by the communities they lived in.

## 2015 Financial Report - Summary

The attached financial reports show that the Foundation improved its fiscal condition during 2015. As shown on the New Balance Sheet report, our available cash position (“Equity”) jumped from \$2,714 at the end of 2014 to \$6,020 at the end of 2015, more than doubling. Just looking at our Checking accounts is misleading, since a large portion of that money was earmarked (“Restricted”) grant dollars, and not available for general purposes.

Cash in our PayPal account also grew, clearly indicating we are getting more online payments than in the past.

Moving to our New Income Statement, revenues dropped in half, from \$38,000 to \$18,000, as a result of closing the Gallery at the end of 2014. However, this was more than offset by the reduction in expenses, primarily facilities related. Program costs also dropped, mainly Instructor Fees. Overall, expenses dropped from \$42,400 to just over \$15,000. As a result, our “bottom line” went from a negative \$4400 in 2014 to a positive \$3300 in 2015.

Normally, we operate on a “cash” basis—we record revenues when received and expenses when paid. However, for grants—especially from Napa County—we need to modify that approach, since we get the money in one year and spend it in the next. As a result, *for grant expenses only*, we recorded the revenues when earned (that is, when we paid for something from the grant!). This means that our grant revenue was much higher in 2015, even though we received the grant in 2014. That is because we spent the grant in 2015.

Finally, since the Art Extravaganza is our biggest fund raiser, we have included a breakdown of revenues and expenses for that event only. As can be seen, the event raised over \$3500, compared to only \$2500 in 2014.

In conclusion, the Foundation improved its condition over the last year, largely due to avoiding rent and overhead from the Gallery and the success of our Art Extravaganza show. We hope to continue that growth into 2016.
